ABOUT OUR ORGANIZATION



The Pinellas County Tax Collector's Office is committed to delivering efficient, accurate, and customer-focused public service to every resident of Pinellas County. From collecting property taxes to issuing driver licenses, our organization plays a central role in providing essential services that support our community.

As an independently elected official and the county's chief revenue officer, the Pinellas County Tax Collector is responsible for collecting and distributing a variety of local taxes, including taxes on real estate, tangible personal property, and tourist development. Each year, our office collects more than \$1 billion in tax revenue. These funds are distributed to the Pinellas County Board of County Commissioners, the Pinellas County School Board, local municipalities, fire districts, and other taxing authorities, ensuring vital services and infrastructure are supported throughout our county. Our annual budget is approved by the Florida Department of Revenue, reinforcing our commitment to transparency and fiscal stewardship.

In addition to our revenue-collection responsibilities, our office serves as an agent for several state agencies. On behalf of the Florida Department of Highway Safety and Motor Vehicles (FLHSMV), we issue driver licenses, identification cards, and titles and registrations for automobiles, trucks, mobile homes, and vessels. We also act as an agent for the Florida Fish and Wildlife Conservation Commission (FWC) by issuing hunting and fishing licenses, and for the Florida Department of Agriculture and Consumer Services by issuing concealed weapon licenses.

Across all services, our focus remains on accountability, operational excellence, and providing accessible and reliable service to the residents and businesses of Pinellas County.


For Fiscal Year 2025, our organization collected \$2,568,510,123 in property taxes. As Tax Collector, my fiscal responsibilities include ensuring the accurate and timely collection, investment, and distribution of public funds, while adhering to a rigorous, transparent budgeting process that operates within statutory guidelines. Once collected, property tax revenue, along with any unused fees from our organization, is distributed to our taxing authorities to fund critical public services, such as fire departments, public health, education, water management, roads, bridges, and more. This year, over \$2.5 billion was returned to the County for essential services.



TAX COLLECTION



Florida's property tax system is a locally administered ad valorem tax (based on value) that ranks below the national average effective tax rate. Taxes are assessed by county property appraisers and collected by county tax collectors, with the revenue funding local services such as schools, law enforcement, and infrastructure. Several factors determine where tax dollars are spent, such as constitutional and state mandates, programs essential to reducing future costs, the rising cost of insurance, the County's Strategic Plan and strategic focus areas, input from citizens during the budget process, and more.


NEW TAX MANAGEMENT AND CASHIERING SYSTEM TO SAVE COUNTY THOUSANDS


The Pinellas County Tax Collector's Office is committed to continuous improvement and innovation in service to our residents. In the coming year, we are excited to implement a new tax management and cashiering system, scheduled to go live on October 1, 2026, coinciding with the start of the new fiscal year. This advanced system is projected to save taxpayers approximately \$1 million annually through reduced overhead costs and lower transaction fees, while streamlining operations and enhancing service efficiency.

In addition, we are planning a new full-service center in North Clearwater within the next few years. This facility will provide convenient access to a wide range of services for residents in the northern part of the county, ensuring that our offices continue to meet the growing needs of the community.
